area, so that we can orient ourselves so where we're talking about next we'll look at going over the purpose and need of this recreation area management plan.

So if you'll go to the next slide will you excellent So here we see an overview map of the planning area.

That area focused in this case will be the highlighted areas.

Except for the area That's on the Northern part of the map, the Blue Creek Wsa.

That was included in the map just because of its close proximity, the planning area, but is not part of the planning area at this time.

On the map. for surface ownership. we have the yellow areas indicate blm public lands.

The blue areas indicate New Mexico State Trust lands, and the Gray is privately owned lands.

You can also see, based on all the different colors of highlighted areas we have here.

There are several different special designations being managed for in the gila lower box at this time.

So the blue area that William is circling now is the Gila Lower Box Special recreation management area.

The green area is going to be the the gila, lower box area of critical environmental concern.

And then, finally, the pink area is going to be the gila lower box wilderness study area.

The only area that isn't actually does not appear on this map that's especially designated area is the gila lower box, wild and scenic river study area which essentially follows the Blue River corridor.

That you see there. I will also note that this ramp only applies to blm. lands, as the blm has no jurisdiction on state trust or private lands.

For a quick overview of those special designated areas and special recreation management area is designated to be managed for primitive recreation.

Opportunities the wilderness study area was designated to manage it as to not impair the area.

Suitability for inclusion into the national wilderness preservation system. And then the area of critical environmental concern was designated to protect and improve the riparian values of the area and finally the the wild and scenic

river study area was designated, for the river to be studied for its suitability for inclusion into the national, wild, and scenic river system.

So lots of different areas that were kind of overlapping here and looking at and considering in in our planning area.

Special designations. I will also note, since this plan specifically deals with recreation, the bulk of the planning efforts will be localized to the 3 public access points into the Lower Box Canyon These are going

to be Nichols canyon road which is far this to the east.

Then fisherman's Point Road and then finally spring on the bluff, also called Spring Bluff Road.

So again, these are the the 3 kind of main public access points into the lower box.

Can you so, William, if you'll go to the next slide, please?

So why is the blm looking at developing a recreation area management plan for the gila?

Lower box. One of the reasons is our previous management Documents call for this plan to be developed.

This includes the Gila River coordinated management plan, as well as the Mimbres Resource management plan, which is our current management plan for the area.

Also, since this area is designated a special recreation management area, a plan must be developed for SRMAs or special recreation management areas to provide the blm direction and give direction on how to manage the areas to meet the

goals of that SRMA, so in addition to these management directives the blm has been seeing an increase in use at the gila lower box.

There's more evidence of vehicle use off of designated routes, more trash and increasing impacts from dispersed camping.

So this recreation plans goal is to look at ways to limit these impacts of this increased use as well as plan for the future visitation.

Use continues to increase the gila lower box is incredibly special place to the local communities in the area.

To us at the Blm and to the unique wildlife and plant species that exist there riparian areas or areas that occur along rivers make up less than 1% of the land here in the las cruces district office But can have as many as

half the wildlife species that occur in the State so clearly very important.

So if we go to the next slide there So this slide kind of talks about preliminary issues that we're seeing kind of mentioned a few before, here this picture, we can see some vehicle tracks

going off the road into the wilderness study area. and and kind of as we spoke about before, we're dealing with a lot of these overlapping special designations in the planning area.

These designations have management prescriptions that the Blm.

Is responsible for upholding. An example of that is that there is no motor vehicle use off of designated routes in the Wsa or the aCec.

The actions proposed in this recreation area management plan will help bringing the gila lower box into compliance with the special designations.

Also with the increase in visitation. Impacts is specifically to the public access.

Points are are becoming worse. there's more trash and there's more evidence of use than ever before.

We believe that it is. we believe part of this is lack of information and infrastructure in the area.

There are no good maps for knowing which routes are open, no kiosk to provide information about what are the allowed uses in the area, and where, So we we think it's important that we come up with a good plan to

solve these issues provide outstanding, primitive recreation opportunities, and ensure the utmost protection for the sensitive biological and cultural resources of the gila.

Lower box. so we'll move on to the next slide there This slide kind of lays out kind of the process for developing the ramp.

So we start there in the upper left hand corner with the Blm.

And contractor gathering information which we've done then.

We move on to drafting kind, of tentative alternatives which we part of. a large part of the reason why we're here to meet tonight is to talk about those, and currently you can see here in the green we're in that

public comment period, looking for The public's comment towards the development of those alternatives.

After that comment period ends. the contractor will draft the environmental assessment and the recreation area management plan.

Then we will go out again for a second public comment on that drafted environmental assessment and recreation area management plan.

And then, finally, the blm. will find it Finalize that Ea.

One of the things I just really wanted to reiterate as we said to get tonight these these alternatives that we were presenting, and kind of the the place we're in right now.

Nothing is set in stone it's just kind of ideas that the blm come up with to kind of get conversation started.

We'll move on to the next slide so this slide kind of lays out small little graphic on kind of how we go through the process of developing our goals as well as strategies and decisions to help implement those goals So you'll see that

first box at the top is gila lower box, guiding principles.

In this case this is going to be any previous management documents as well as any of those special designations that we talked about, and the kind of main themes that come from those are resource protection and primitive recreation.

So with those guiding principles, we move into development of the ramp goals which is looking at what types of W.

What's the outcome we're looking from for this area what are our main goals in the area that align with those guiding principles? and there's kind of 2 main themes for that that's going to

be the recreation of recreation, uses experiences and settings, and then the infrastructure and administration. and then, finally, we move into building of ramp strategies and decisions.

These are kind of the on the ground decisions that we that we hope to make in order to help us reach those goals that we set out for a new plan

So as a quick example for that you know one of the ramp's goals might be to limit the off-road driving into the Wsa.

At the end of fisherman's point and spring on the bluff road, a strategy that could be implemented from that would be to install kiosk near the entrances of those roads to provide maps and information to

00:18:02.000 --> 00:18:06.000

the visitors about where those boundaries are and where they're allowed to drive.

00:18:06.000 --> 00:18:11.000

In addition, establishing trail heads and parking areas at the end of both of those roads.

00:18:11.000 --> 00:18:18.000

For the 2 trails that currently exist. provide visitors at designated place to park, so that the impacts will be concentrated to those parking areas.

Only those parking areas which currently we're seeing kind of dispersed camp parking all along those roads in the wilderness study area.

So that's kind of an example. of how goals might inform strategies, decisions which would then help us reach our goals.

So we'll move on to the next slide William

We kind of touched on this before, but these are our kind of 2 main themes.

First name there recreation, use experiences and settings this focuses on visitor experiences and incorporate steams from outcome focus management approaches in the blm handbook 8300 and

20 which is planning for recreation and visitor services.

So this considers characteristics that would contribute to positive recreational outcomes.

Visitor, safety, natural resource, and and natural resource protection.

The second theme is administration and infrastructure.

This see theme is more geared towards site, utilization, administration, accessibility, safety, and includes topics, as you see around the slide, such as visitation management facilities, infrastructure, roads and parking and

partnerships, and next slide, William. so this slide we kind of break down these these 2 themes into kind of proposed management themes within the theme.

So this is kind of a list of some of the proposed management themes within the recreational uses, user experience and settings goal, so that first one, their resource protection of course, protecting wildlife threatened endangered species and cultural

resources the next one primitive recreation. These are again like we talked about the management directives prescribed by the the special recreation management area and acec designations.

Then also compatible recreational uses it's important that we plan for recreation uses that are compatible with these special designations, as well as other uses occurring in the area such as

grazing trails and access improving trails currently on the ground, and looking for opportunities to provide more a better access where appropriate just could also include creating a official trail heads and parking which don't exist

00:20:33.000 --> 00:20:45.000

at this time. public safety always doing our best to limit the inherent risks that come with outdoor recreation, and always in prioritizing human life over all other management actions.

Special designations management, which is the management of a recreation to eliminate eliminate conflicts with the Wsa.

00:20:52.000 --> 00:20:57.000

and area of critical environmental concern. and finally, education, interpretation.

This is providing education, interpretation to the public about the area, including information about geology, archaeology, biology, paleontology, essentially, so that they might learn and grow greater appreciation for the lower box.

And if you go to the next slide there, William, so just like before, this is more proposed management themes for the in this case the administration and infrastructure goal.

So that first one there partnerships and key stakeholders ensuring, we work with local communities, organizations and permit holders to help monitor and make improvements to the area as well as solve complex facilities maintenance

and improvements. making sure we maintain existing facilities and look for opportunities to provide improved facilities for visitors, such as creating trail heads, dispersed camping areas.

This improves this improves visitor experience, while also protecting resources roads and parking which is properly communicating condition of roads and providing established, parking areas.

And then, finally, visitation management, which is the development developing a monitoring plan to look at visitation trends and ensuring areas do not exceed their capacity or cause resource damage.

Which we are seeing now, so that in my section of the presentation and i'll pass it on to Allie to talk a little bit about the tentative alternatives that we've kind of come up with to talk about today awesome

So put that in the chat So we have developed 3 different alternatives for each area in the gila lower box.

There are 5 different areas in the gila lower box planning area that are along the different access routes that Stephen mentioned.

These alternatives include an alternative, a no action alternative which basically shows what is existing on the ground in present day.

Alternative B or a proposed action it's kind of our best case scenario right now again, these are tentative and alternative c.

Or a more minimal disturbance alternative with less infrastructure to be proposed.

The first area We're going to look at is the Nichols Canyon flood plain, which is the most popular area in the gila lower box, and most of the flood plain is in an area of critical environmental concern

which has certain stipulations, such as no new roads and trails.

We are now going to go through each tentative alternative. for the Nichols Canyon flood plain.

Next, slide, please,

So this is the No action alternative. The map shows the current road into Nicholas Canyon.

The purple portion of the road has partially washed out, and new routes are being created by public recreation is all throughout the flood plain.

In this area. Okay, next slide, please. the proposed action Alternative includes a few different infrastructure projects the blm would fix washed out road and add a water diversion to protect the road in the future add

a boating takeout for folks that decide to float into the campsites, add a parking area that would have a post in cable around it to kind of keep people in the parking area 4 to 6 primitive walk-in

00:24:53.000 --> 00:25:09.000

camping sites that would only have a fire ring, and those would fall somewhere within that brown area, and then a trail leading to the boating takeout and camping sites and signs would be added to an existing electric cattle sense

that spans across the river that would allow folks to know that it is electrified.

00:25:15.000 --> 00:25:22.000

Okay, next slide, and then the minimal disturbance alternative.

A gate would be installed at the beginning of Nichols Canyon Road, to limit all motorized access for administrative use.

The public would still be able to access 4 to 6 primitive camp areas and a small interpretive area down on the Nichols Canyon flood plain by hiking in along the old Nichols Canyon Road

or by floating in when the rivers running. there would be no further road reclamation.

This alternative would also include signs on the electric fence.

Not seen on this map. It has been proposed also, and perliminary discussion.

To put a parking area near a spring that is off of Nichols Canyon Road.

Then the public would park at that parking area and be able to hike down to the flood plain, and it would allow them to get a little closer.

Okay, next slide, please. the second area and the gila Lower box is the gauging station area which involves a road that drops down to the United States Geological Service gauging station.

There is also a wilderness study area to the south of the road.
